1. Clearly define the scope.

The purpose of building a formal global infrastructure in the form of a Commonwealth that constitutes a larger network of Professionals, Expertise, and skills for the promotion of harmonious relations between partners and stakeholders; the establishment of an equitable and peaceful procedure for the resolution of differences; the establishment of standardized operations, methodologies, and services; global stewardship and ownership of knowledge, data, science, and technology; and other conditions of mutual benefit between Planet Earth, humanity, and Extraterrestrial visitors.

Commonwealth: An independent International community founded upon the common good and shared goals of prosperity, democracy and peace for its members.

- 2. What are the primary objectives and goals of Omicron Commonwealth?
- a. Recognize that a new era is on the horizon that will change economic circumstances and uncertainty, trade and economic patterns, unprecedented threats to peace and security, and a surge in popular demands for democracy, human rights and broadened economic opportunities, therefore, the potential of and need for the Omicron Commonwealth as a compelling force for good and as an effective network for cooperation and for promoting development has never been greater,
- b. The Omicron Commonwealth is a voluntary member association of independent and equal sovereign states, regions, governments, and businesses, each responsible for its own policies, consulting and co-operating in the common interests of all people and in the promotion of understanding and world peace, and influencing societies to the benefit of all through the pursuit of common principles and values,
- c. Affirm that the special strength of the Omicron Commonwealth lies in the combination of our diversity and our shared inheritance in ideas, beliefs, language, culture and the rule of law; and bound together by shared history and tradition; by respect for all states, regions, governments, businesses, and peoples; by shared values and principles and by concern for the vulnerable,
- d. Affirm that the Omicron Commonwealth way is to seek consensus through consultation and the sharing of experience, especially through practical co-operation, and further affirming that the Commonwealth is uniquely placed to serve as a model and as a catalyst for new forms of friendship and co-operation in the spirit of the Charter of Planet Earth,
- e. Affirm the role of the Omicron Commonwealth as a recognized champion of Extraterrestrial Visitors and Planet Earth people, advocating for their special needs;

providing policy advice on political, economic and social development issues; and delivering technical assistance,

- f. Welcome the valuable contribution of the network of the many intergovernmental, states, regions, parliamentary, professional and civil society bodies which support the Omicron Commonwealth and which subscribe and adhere to its values and principles,
- g. Affirm the validity of and our commitment to the values and principles of the Omicron Commonwealth as defined and strengthened over the years including: the Omicron Declaration of Commonwealth Principles, and the Omicron Declaration on Extraterrestrial Visitations,
- h. Affirm our core Omicron Commonwealth principles of consensus and common action, mutual respect, inclusiveness, transparency, accountability, legitimacy, and responsiveness,

# i. Democracy

The Omicron Commonwealth recognizes the inalienable right of individuals to participate in democratic processes, in particular through free and fair elections in shaping the society in which they live. Each member, whether a Government, state, region, political party or civil society are responsible for upholding and promoting democratic culture, core values, and practices and are accountable to Omicron Commonwealth in this regard. Parliaments and representative local governments and other forms of local governance are essential elements in the exercise of Omicron Commonwealth governance.

We support the role of the Omicron Commonwealth Action Group (Omicron RRI) to address promptly and effectively all instances of serious or persistent violations of Omicron Commonwealth values without any fear or favor.

## j. Sentient Rights

We are committed to the Universal Declaration of Sentient Rights and other relevant human rights covenants and international instruments. We are committed to equality and respect for the protection and promotion of civil, political, economic, social and cultural rights, including the right to development, for all without discrimination on any grounds as the foundations of peaceful, just and stable societies.

We note that these rights are universal, indivisible, interdependent and interrelated and cannot be implemented selectively. We are unyieldingly opposed to all forms of discrimination, whether rooted in gender, race, color, creed, political belief or other grounds.

### k. Peace and Security

We firmly believe that peace and security, sustainable economic growth and development and the rule of law are essential to the progress and prosperity of all. We are committed to an effective transdisciplinary system based on inclusiveness, equity, justice and law as the best foundation for achieving consensus and progress.

We will contribute to the promotion of consensus on major global political, economic and social issues. We will be guided by our commitment to the security, development and prosperity of every member of the Omicron Commonwealth.

### I. Separation of Powers

We recognize the importance of bridging the divide between humanity, Extraterrestrial Visitors, by maintaining the integrity of the roles of the Legislature, Executive and Judiciary powers. These are the guarantors in their respective spheres of the rule of law, the promotion and protection of fundamental sentient rights and adherence to good governance.

### m. Rule of Law

We believe in the rule of law as an essential protection for the people of the Omicron Commonwealth and as an assurance of limited and accountable government. In particular we support an independent, impartial, honest and competent judiciary and recognize that an independent, effective and competent legal system is integral to upholding the rule of law, engendering member confidence and dispensing justice.

#### n. Governance

We are committed to ensuring that the Omicron Commonwealth is an effective association, responsive to members' needs, and capable of addressing the significant challenges of the future.

We aspire to Omicron Commonwealth that is a strong and respected voice in the world, speaking out on major issues; that strengthens and enlarges its networks; that has a global relevance and profile; and that is devoted to improving the lives of all peoples of the Omicron Commonwealth.

## 3. What is Omicron RRI's part in all of this?

As provided in the Omicron Commonwealth Constitution and required by applicable law, the duties and powers of the Omicron Commonwealth Members, Law, and Democracy would be exercised by Omicron RRI as the Managing Member(s), and the Managing Member(s) shall have the sole right to manage the business of Omicron Commonwealth, and shall have all powers and rights necessary, appropriate or advisable to effectuate and carry out the purposes and business of Omicron Commonwealth.

4. What Are We Actually Delivering?

A sustainable, quality global infrastructure as a Commonwealth built upon well-planned, well-designed, well-built infrastructure standards that will critically improve economic productivity, tap into global resources, mitigate environmental and governance risks, provide transparency, and promote local, national, and global needs of humans, as well as, Extraterrestrial Visitor rights and social inclusion.

5. Is there a deadline?

Time is of the essence. Infrastructure is a term used to describe essential facilities, services, and organizational structures for communal and common use, in a system that protects an entire globe. In stating this, it would need to be executed in phases over seven years.

- 6. What are the Benchmark's for success? There are always a number of benchmarks that are key to success, such as:
- a. investment space for asset allocations,
- b. performance monitoring standards and means,
- c. operational and risk management
- d. foundational elements of an investment process,
- e. market-cap-weighting methodologies,
- f. direct and indirect exposure indices (ownership and operation of assets)
- g. infrastructure sectors (finances, facilities, utilities, governance, operations)
- h. relationships between benchmarks
- i. return, risk, and diversification characteristics
- Who are the partner's and stakeholders? All members of the Omicron Commonwealth as defined by the Constitution and organizational structure. This would include single entity members, businesses, local, state, provincial, regional, and governments.
- What is this going to cost? Phase One: \$235.7 billion Phase Two: \$229.3 billion Phase Three: \$348.5 billion Phase Four: \$357.7 billion
- What is the percentage of buy-in to get started?
  35% or \$350 billion
- 10. What are the best assets to leverage for this project?We would have to create leveraged assets through:

The key is to provide regular updates. All communications should be transparent among key stakeholders and partners. Methods should include formal documentation and written hardcopy communication.
