

WHY IS DISCLOSURE IMPORTANT

WHAT IS DISCLOSURE

It requires disclosure to change the cognitive state of an individual. Cognitive dissonance refers to the mental discomfort or tension that arises when a person holds two or more contradictory beliefs, values, or attitudes simultaneously. It is a state of psychological conflict that can occur when there is a discrepancy between one's beliefs and actions, or between one's beliefs and new information or evidence. This accounts for the differences in belief of the existence of Extraterrestrial life/UAPs/etc.

Disclosure comes down to the influence of the adaptive cognitive state of an individual. First, understand that cognition is the states and processes involved in our individual knowing. These states include all conscious and unconscious processes by which knowledge is accumulated, such as perceiving, recognizing, conceiving, judging, and reasoning. Second, our cognition is a state or experience of knowing that can be distinguished from our experience of feeling or willing.

So, we need disclosure to be the timely release of acts or actions, and process of relevant and pertinent facts, data, or information to come into public awareness. The key concept about disclosure is that it requires increased transparency to mitigate the manipulation and misuse of information because relevant information refers to any and every piece of information, including facts, figures, dates, procedures, innovations, and so on, whether advantageous or disadvantageous, positive or negative, fortunate or unfortunate that can potentially influence decisions.

For most individual's, information is processed through assimilation and accommodation. Assimilation becomes the process of interpreting reality in terms of an individual's internal model of the world, which is formulated on previous experience; whereas, accommodation represents the changes the individual makes to that model through the process of adjusting to experience. Furthermore, the process of assimilation is about desensitizing an individual to the information by graded exposure or other processes to diminish emotional responses to negative, aversive, or dissonant stimuli through repeated exposure.

AND IT BEGINS

Officially, the Senate passed "The UAP Disclosure Act of 2023" as part of the National Defense Authorization Act for 2024, and it sets up a timeline and process to deal with reports of unidentified aerial phenomena (UAP) by forcing government agencies to hand over any records on UAP/UFOs within a

specified period and mandates the disclosure of those records to the public unless there is a compelling reason to keep them classified.

The amendment was passed July 2023 at the same time a hearing in the House was held featuring David Grusch, who came forward with allegations that the Pentagon has a UFO retrieval program that has been kept secret from both the public and Congress.

Lest we forget the abundance of previous information released. By no means is this all of the reported data. How much proof and/or evidence is needed to convince an individual in the existence or reality of something?
