

### INTRODUCTION OF INTEGRATED INTERAGENCY TASK FORCE


This Omicron Joint Task Commitment Brief (OJTCB) proposes the formation of a closely Integrated Interagency Task Force (2ITF) between the Sovereign States of these United States, Federal Agencies, and other Global Partners and Stakeholders to Research, Investigate, and Recover critical mission data and evidence associated with Extraterrestrial Visitations, whether as an Unidentified Aerial Phenomenon (UAP), Unidentified Flying Object (UFO), Unidentified Submersed Object (USO), or Unidentified Foreign/Alien Technology (UFAT).


Currently, methods and efforts challenge solo entities and private sector businesses to provide maximum capability with minimum resources. In order to meet this challenge effectively, the United States must become a leading and guiding source, while taking full advantage of the synergy provided by the disclosure of purported Extraterrestrial Visitation activities.

These well-trained, combined Task Forces could be employed and deployed in a wide variety of Research, Investigation, and Recovery missions that frequently change and evolve during development and

execution. ### DEFENSE DEPARTMENTS AND INTELLIGENCE COMMUNITIES

This OJTCB is addressing the purported development of a Defense Department and Intelligence Community office, whose mission statement focuses on Unidentified Aerial Phenomenon (UAPs) and have defined their mission as providing the resources, analytics and attention focused on National Security issues and the recovery of technologies. For nearly seventy years the US government has engaged in an extensive "official effort" of disinformation, intimidation and tampering with evidence in order to maintain a non-disclosure policy about extraterrestrial presence.

It is not in the best interest to the people of Planet Earth, that the Defense Departments and Intelligence Communities become the overriding authority for such a complex field of study and investigation regarding Extraterrestrial Visitations. This OJTCB suggests a very strong conflict of interest between the Defense Departments and Intelligence Communities and neither party could perform their duties appropriately because it would mean betraying their interests to one of the parties within the situation. Therefore, full disclosure would never be an option, much less attained.

Defense Departments and Intelligence Communities have long been stigmatized with serious deficiencies in mission planning, command and control, and interservice interoperability, as well as, misrepresenting

and withholding critical data, discrepancies or misuse of analytical and data reports, incident cover ups, and non-disclosure, which has succeeded in adverse effects and distrust towards these Government Entities throughout the communities and populations of the World. If we are to provide the People of these United States, much less the populations of Earth, with full disclosure regarding Extraterrestrial Visitations, then it is necessary to remove the stigmatisms of the singular aspect to National Security and move this into the areas of transdisciplinary studies.

This OJTCB further notes that Defense Departments and Intelligence Communities build their core from subordinate component commands augmented by specialists and other service component resources with the core mission of National Security. It should also be noted that commands choose their core headquarters based on ability to perform specific missions and must augment from other services appropriately. This OJTCB, therefore concludes that Defense Departments and Intelligence Communities currently lack the ability to train and organize effectively for Research, Investigation, or Recovery of Extraterrestrial Visitation Incidences or Events. This OJTCB further suggests that continued improvement through a global transdisciplinary approach is required because current doctrine for training Defense Departments and Intelligence Community joint task forces is immature and the training programs implementing the doctrine are relatively new.

#### BENCHMARKS FOR AN INTEGRATED INTERAGENCY TASK FORCE

The 2ITF would design, implement, and operate to the premise that Science is never about one main idea, but rather the culmination of thoughts, theories, and ideas of multidisciplinary data presented as regular (meaning varying around some theoretically 'stable' equilibrium), random (meaning completely unpredictable), or chaotic sources and systems. Therefore, all policies, guidelines, research, findings, criteria, and data, must be used to coordinate the coherent integration of results into scientific discourses, and related transdisciplinary fields, in advancing our comprehension, and innovating this field of Extraterrestrial Visitation research, with an independent voice of free information.

All globalized 2ITF partners would identify challenges, provide considerations and expertise for future scientific study designs, and recommend courses of actions to define multi-sectoral and multi-faceted research in a variety of disciplines such as:

- A. Global Alliance Interdisciplinary Scientific Teams to engage in the study of Extraterrestrial Visitation phenomenon using global standardized procedures, methodologies, and protocols.
- B. Global Alliance Research and Development Service Corps to study the material, form, use, and function of recovered technologies, as well as, develop future form, use, and functions of technologies.
- C. Global Alliance Protocol and Liaison Service Corps to study, develop, and maintain high-quality, standardized services, uniform set of rules, governing codes of behavior, and strategic vision protocols between Extraterrestrial Visitors and internal Earth communities.
- D. Global Alliance Strategic and Distribution Service Corps to study, design, and implement uniform set of rules, governing codes of production, use, marketing, storage, and distribution of technologies released from Research and Development Service Corps recovered during Extraterrestrial Visitation investigations.

- E. Global Alliance Genetic and Medical Corps to research, study, develop, implement, and maintain high-quality, standardized biological and genetic services, standardized medical services, uniform set of rules, governing codes of conduct and behavior, and strategic environmental, safety and health protocols related to Extraterrestrial Visitors and the populations of Earth.
- F. Interdisciplinary study of processes involving energy consumption, energy harvesting, electromagnetic waves, zero-point energy, dark energy, and new fuel methods.
- G. The research and exploration of Interdimensional travel or the interdimensional hypothesis (IDH or IH), in which, UAPs, UFOs, or related events involve visitations from other realities or alternate dimensions that coexist separately from our reality.
- H. Global Alliance Exopolitics Service Corps to study, develop, and implement as a new synthesis of transdisciplinary study by key individuals, political institutions, academia, and processes associated with extraterrestrial life.
- I. Interdisciplinary Studies of the Extraterrestrial Hypothesis (ETH), extraterrestrial life, genetic and cultural intervention, and the Extraterrestrial Visitation contact/experience.
- J. Develop civilian, scientific, anthropological, and academic research studies to include Hyperdimensional Hypothesis (HDH); the Ultraterrestrial Hypothesis (UTH); or the Superintelligence Hypothesis (SIH).
- K. Globalized Military UAP investigations that postulate unacknowledged unconventional exotic technology possessed by foreign or domestic nations, exhibiting the behavior of some UAP cases.
- L. Globalized Military UAP investigations and threat mitigation from the standpoint of Planetary Security and Intelligence.
- M. An interdisciplinary study of cultural impact between extraterrestrial contact and the countless changes to terrestrial science, technology, religion, politics, and ecosystems resulting from contact with an Extraterrestrial Visitation.
- N. Global Alliance Immigration and Welfare Service Corps to study, design, implement, and maintain high-quality, standardized documentation, policies, counseling, advocacy, support services, relocation, and deportation services between Extraterrestrial Visitors and the populations of Earth.

### SUMMARY

To an observer from the outside, there may be concerns about our current state of affairs and the behaviors exhibited by the inhabitants of Planet Earth.
