



### 1. WHY IS OMICRON COMMONWEALTH (OC) A MILITARY STRUCTURE?

### 2. WHAT TYPE OF FINANCIAL SYSTEM WILL OMICRON COMMONWEALTH HAVE?

The Omicron Commonwealth (OC) Financial System is based on the greater cosmic community credit system. ### 3. DOES A MEMBER HAVE TO PAY ANY MONEY?

A "Consumption Contribution" fee (currently figured at \$2400 per year per member) will be paid into the Omicron Commonwealth financial system by each member and invested into the Commonwealth's broad social safety net and public funding of services such as universal health care, education, and

housing to serve each Omicron Commonwealth member. The OC government will have overall managerial and financial responsibility for medical and hospital services. - 3) Foster transformations, innovations, and investments through our policies
- 4) Platforms for international cooperation and economic growth, and
- 5) Identify sources of innovative finance across the Commonwealth

#### 4. WHAT ARE THE THREE PHASES OFOMICRON COMMONWEALTH?

##### A. PHASE ONE: CREATING THE LEGAL FRAMEWORK FOR OMICRON COMMONWEALTH TO STAND UP AS A SOVEREIGN NATION OF PLANET EARTH

- Illicit drugs, firearm trafficking, and illegal market activities are identified as multipliers of violence, competition, and the Global economy.
- Human density accounts for over polluted communities, damaged waterbodies, and uncontrolled, mountains of garbage
- Humans persecute and prey upon their own kind with slavery and human trafficking,
- Humans commit violence and war against each other, and
- Humans are highly vulnerable to annihilation by self-inflicted wounds, such as nuclear wars or climate change.

The Omicron Commonwealth has been designed to mirror and develop under the cosmic community platforms to become a sustainable and resilient environment that provides the people of Planet Earth with a voice in the greater cosmic communities. In Phase One, we must build it to BECOME. There are key conditions that must be met to become a sovereign nation of Planet Earth:

- ✓ **The Omicron Commonwealth National Anthem titled “Galactic Dust National Anthem” with lyrics to represent Unity, Pride, Perseverance, and Strength of the Omicron Commonwealth people.**
- 3) We must have a formal government system developed, designated, and given authority to operate, enforce organizational policies and laws, provide protection for its population from outside interference, determine and implement policies that affect the well-being and happiness of the population, and lead and govern the people within its territory.

- 6) We must have a permanent, defined population.

- 7) We must have described roles and responsibilities of government officials and appointed Head of the Nation.
- ✓ **The Omicron Commonwealth Head of the Nation is the Chancellor and Commander-in-Chief of the Military Service Corp. The Executive Staff of the Military Service Corp are appointed to key government positions designated under The Omicron Commonwealth Charter Agreement and The Omicron Commonwealth Prime Directive.**
