



EXTRATERRESTRIAL HUMAN TRAFFICKING AND ENSLAVEMENT SEPTEMBER 2015

This document is a short overview of the Extraterrestrial Human Trafficking and Enslavement Program.

While we may not agree with the concepts and philosophy of trafficking humans and enslavement, Planet Earth is not guiltless of this crime against humanity. Throughout our own Planet Earth history, slave trade or the trafficking of humans is nothing new. Human trafficking, also known as trafficking in persons, is a crime that involves compelling or coercing a person to provide labor or services, or to engage in commercial sex acts. Enslavement is the state or condition of one individual being owned by another individual to be held in slavery without freedoms or rights.

There are no real defining characteristics that human trafficking victims share. It occurs regardless of race, color, national origin, disability, religion, age, gender, sexual orientation, gender identity, socioeconomic status, education level, or citizenship status. These traffickers generally prey on individuals whose vulnerabilities such as poverty, language barriers, or unlawful immigration status, are exacerbated by lack of stable, safe housing, and limited economic and educational opportunities. This constitutes a multi-billion-dollar business on Planet Earth. Image what it would be on a Galactic level.

There are several Extraterrestrial species that admittedly use Earth humans as a commodity for trade with other off planet civilizations for exploitation, genetic engineering, military projects, sex slavery, food, play-pets, slave workforce, and an assortment of Negative Aliens (NAA) agendas designed to further enslave and torture humanity.

- Wreckage from a huge colony ship that was identified during NASA studies concluding it is a material found in only one place on Earth
- Genetic engineering of Homo sapiens from an early hominin species is confirmed with a lengthy list of DNA anomalies only explainable by humans being an alien 'hybrid' creation
- Certainly the recent studies of UFOs, UAPs, and other anomalous phenomena
- Ancient artifacts that indigenous people attribute to Star people, and

- The theory that an extraterrestrial modified retrovirus was used to deliver some of the genetic information into upgraded humans

For many of the Extraterrestrial species, there is no association with the belief or emotional attachment to the meaning of “Ethics”. After all, many civilizations don’t understand the concepts of corruption and greed, so it would make sense that they would not view the slavery and trafficking of humans in the same way that we do. For many Extraterrestrial species, they legitimize and reduce the reasoning of human trafficking and enslavement to their need for genetic engineering. This is the real reasons for the “Survival of the Fittest” theory. For several species, they have evolved to a near state of extinction, through the inability to procreate or reproduce.

For billions of years, the history of life has been written with just four letters: adenine (A), thymine (T), cytosine (C) and guanine (G). These letters represent the code for the amino-acid building blocks that make up proteins. The bases bind the two DNA strands together, with an A always bonding to a T on the opposite strand (and vice versa), and C and G doing likewise. But what if you could pair chemicals together that could create unnatural, foreign bases that could be copied and transcribed into RNA. For a technologically advanced Extraterrestrial, this is normal business.

In many instances, the enslavement of humans is considered legal in the galactic territories. For many of these cases, enslavement is a result of breaking the law, becoming indebted, suffering a military defeat, or exploitation for cheaper labor; while other forms of slavery are instituted along demographic lines such as genetics, race or sex.

What this does is make the human genome valuable to Extraterrestrial research and inevitably repeats the cycles of intelligence versus enslavement for humanity. Throughout our own history, scientist have been able to observe differences in intelligence quotients between different population groups, and there have been arguments over whether this is mainly due to environmental and cultural factors, or mainly due to some as yet undiscovered genetic factor, or whether such a dichotomy between environmental and genetic factors is the appropriate framing of the argument, but either way, it has always played a central role in racism. Much of the current evidence supports or justifies the racism inferiority or superiority argument. This genetic connection is the basis for interpretations and sociopolitical phenomena of human evolution, intelligence, ethnography, language, mythology, archaeology, and race.

Earth tends to mirror otherworldly principles such as in the industrialized worlds, human trafficking is a modern variety of slavery; in non-industrialized worlds, enslavement by debt bondage is a common form of enslaving a person, such as captive domestic servants, people in forced marriages, and child soldiers.

Moreover, the profit funds are moved through intricate networks, using systems both within and across countries, as well as planetary systems, and Extraterrestrial civilizations. This trade equates to billions of dollars that are laundered through legitimate financial institutions.

Right now, there is no real answer to understanding this phenomenon. The depth and magnitude of these types of operations are outside the scope of understanding the how, why, where, and when this is happening. Many agencies are employing artificial intelligence technologies to begin to learn more about the patterns, nature of this business, ownership, and processes.
